**Invitation to Attend the 2024 Philip C. Jessup International Law Moot Court Competition**

To Whom It May Concern:

My name is Michael Peil, and I am the Executive Director of the International Law Students Association (ILSA). ILSA is a non-profit organization headquartered in Washington, DC, whose mission is to support the study and practice of international law. ILSA owns and administers the Philip C. Jessup International Law Moot Court Competition (“the Jessup”), the world’s largest simulated court competition.

I write today to formally invite a delegation of law students and coaches from Shantou University to attend the White & Case International Rounds of the 2024 Philip C. Jessup International Law Moot Court Competition.

Now in its 65th year, the Jessup is the world’s largest moot court competition for law students, with participants from more than 700 law schools in over 100 different countries and jurisdictions. Participating jurisdictions hold national competitions to determine their respective representatives to the International Rounds, which are held annually in Washington, DC. Sponsored by the international law firm White & Case LLP, this year’s International Rounds will be held 30 March - 6 April 2024, at the Hyatt Regency on Capitol Hill, 400 New Jersey Avenue NW, Washington, D.C. 20001.

Over the years, the Jessup Competition has been sponsored and supported by the United States federal government, including through grants from USAID, the Department of State, and the Department of Justice. The Jessup Competition has been recognized as playing an important role in public diplomacy and in advancing U.S. interests in the rule of law and democracy.

Students competing in the Jessup argue a hypothetical dispute between two fictional countries before a simulated International Court of Justice. Each competing team is required in January to submit two written arguments of approximately 40 pages each, and to prepare 90 minutes of oral argument.

Through its hard work, the team of students from Shantou University has qualified to represent China at the White & Case International Rounds. During the week, the team will compete in four preliminary oral rounds that will determine the top 48 teams in the world. These 48 teams will then compete in the advanced rounds that ultimately will determine the World Champion.

The week also includes social events so that the students can befriend other future lawyers from around the world. These include our highly attended “Go National” dress ball and a black-tie Awards Reception and Gala. Finally, the team will attend the White & Case World Championship Round on Saturday 6 April, where the two top teams will square off before a distinguished panel of the most highly qualified judges, practitioners, and scholars.
